- 87. State any achievements or actions you have accomplished, demonstrating your professional abilities and or your commitment to equal justice under the law:

I have been a member of the Chief Administrative Judge's Matrimonial Practice and Rules Committee (MPARC) since 2014. This is a statewide committee, chaired by Hon. Jeffrey Sunshine, and comprised of judges and eminent members of the matrimonial bar from all judicial districts in the State of New York. MPARC advises OCA on issues concerning the practice of matrimonial law, including new legislation and practices. Among other things, the Committee has been instrumental in the implementation of the new maintenance law, the change of the rules to strengthen enforcement by contempt applications in Supreme Court and a recent change in the forms for Preliminary Conference and Statement of New Worth. I was the only Court Attorney Referee and the only person from Staten Island on the Committee.

In late 2015, I, along with members of MPARC and the Office of Court Administration's Dept of Technology helped create the first ever calculator and worksheet which allows the public to calculate the possible awards of post-trial child support and maintenance, based on the new maintenance statute (eff. January 2016). Calculators of this kind did not exist prior to this time. A prior online tool for the calculation of temporary maintenance was only available to private practitioners who could purchase the relevant computer programs.

I believe this calculator and worksheet are invaluable to litigants who are self-represented and to practitioners in small practices. It allows them to have the very same tools the

courts use in making their decision, giving them important information with which to prepare
themselves for trial or settlement.
All my work on the MPARC is voluntary. This project took about 75 hours over a
three-month period. After the calculator was created, I, along with my colleague who is Counsel
to MPARC, taught a webinar and participated in Q&A forums on its use for members of the
judiciary.
I remain on this committee despite leaving the court system, at Justice Sunshine's
specific request.

Prior to my appointment to my current position, I have had 20 years of experience and service in the Unified Court System. I am familiar with all the work of a busy Court part and served as an actual trial part for 8 years. I am deeply committed to the work of the courts and understand the value and importance of a judiciary committed to justice.

Personal Statement of Hemalee J. Patel

Until March 2021, I was Court Attorney-Referee in Richmond County Supreme Court, where I conducted trials and hearings on financial issues in matrimonial matters, including equitable distribution, child support and maintenance. My duties included issuing decisions or reports in a timely manner, supervising discovery and deciding motions, including post-judgment applications. I was also responsible for the management and administration of my own calendar and part and gained valuable experience in the logistics of scheduling and conducting trials. Further, I became very familiar with administrative requirements and court computer systems, such as Case Management and CCIS.

At all times I strove to conduct my work in a serious, patient, and thoughtful manner. All litigants are, of course, entitled to have their day in court and I know it is important, especially in Matrimonial actions, that the court have access to all vital and competent evidence available, so that a reasoned and fair result may be reached. Nevertheless, I recognized that the parties are often better served by a settlement of the very personal and sensitive issues in divorces, as this can save them the considerable financial and emotional costs of litigation.

In working with attorneys, I always kept in mind and respected the calendar management issues faced by those in small or solo matrimonial practices in Richmond and Kings County. I also gained extensive experience with self-represented litigants.

The quality of our lives is directly and deeply influenced by those who serve the public and I considered myself privileged to be a civil servant—and tried always to be one in the truest sense. This meant, to my mind, that I did my best and conveyed that intention by being at all times honest, fair and courteous to the parties and attorneys who appeared before me. Beyond that, I believed that the quality of my work and persona should have inspired confidence in our judicial system and address the needs and requirements of both the litigants and the court.

In my personal life I have strived to be a positive influence in my various communities, and to be a role model for my children, as I deeply believe in my responsibility to change my world for the better.

As an immigrant South Asian woman, I have a unique perspective that, along with my background, experience, and proven ability in performing the duties and responsibilities of a Court Attorney-Referee, prepares me to undertake a career as a judge.

The Office of the General Counsel ("Office") provides legal advice and guidance to the Board of Elections in the City of New York ("Board") on a wide range of matters relating to ballot access, the conduct of elections, and agency administration.

ADMINISTRATION

The Office recommends revisions of formal Board policies and procedures to ensure compliance with applicable statutes and regulations. The Office provides legal advice and guidance to Board staff as requested. The Office acts as a liaison with the New York City Conflicts of Interest Board with respect to the administration of applicable conflicts of interest provisions found in Chapter 68 of the New York City Charter.

BALLOT ACCESS

The Office drafts, for consideration and adoption by the Commissioners of Elections, all election calendars and the proposed Rules for Designating and Independent Nominating Petitions for each election cycle. The Office also oversees all aspects of the process for candidate filing and Board review of Designating and Nominating petitions, cover sheets and/or certificates. The Office maintains a good working relationship with the New York State Office of Court Administration with respect to the Judiciary's activities in connection with the electoral process. In addition, the Office provides guidance and support for the conduct of the canvass of votes mandated by Article 9 of the Election Law and the Board's Policies and Procedures.

COMPLIANCE ACTIVITIES

The Office advises the Commissioners on all elements of the Board's legal compliance with all applicable statutory and regulatory requirements. Any proposed change in election administration affecting voters is reviewed by the Office before being presented to the Commissioners for approval. The Office acts as the Board's liaison with other governmental regulatory and investigatory agencies, including the United States Department of Justice, the local United States Attorneys' offices, the New York State Attorney General's Office, the District Attorneys of the five counties within the City of New York, the New York City Department of Investigation, and the Inspectors General for various City agencies.

LEGISLATIVE ACTIVITIES

The Office regularly monitors all legislative and judicial actions that impact election administration and advises the Commissioners on all legal developments, including statutory compliance with City, State, and Federal mandates related to the Voting Rights Act, the Military and Oversees Voters Empowerment (MOVE) Act, the Help America Vote Act (HAVA), the New York State Election Law, the New York City Charter, and related judicial directives. In addition, the Office drafts for

consideration by the Commissioners the Board's annual recommendations for revisions in the New York State Election Law for presentation to, and consideration by, the New York State Legislature and the Governor.

LITIGATION

The Office acts as the Board's principal point of contact with the New York City Law Department, which usually represents the Board in all litigation matters involving the Board of Elections, its operations, and personnel. Throughout 2021, the staff of the Office assisted the assigned Assistant Corporation Counsels in litigating various matters, including those related to ballot access, poll site designations, poll site accessibility, voter registration systems, employee discipline as well as various tort claims against the Board. In addition, the Office represents the Board before various administrative tribunals.

PERSONNEL MATTERS

Section 3-300 of the New York State Election Law empowers the Commissioners to appoint and remove at their discretion all employees of the Board. In accordance with the collective bargaining agreement entered into by the Commissioners and Local 1183 of the Communications Workers of America, AFL-CIO, the Office conducts all administrative hearings required under that agreement for Board employees. It is also responsible for resolving employee disciplinary matters prior to a formal hearing through negotiation, pursuant to the direction of the Commissioners of Elections and the agreement of Local 1183.

FREEDOM OF INFORMATION LAW

The Office receives, processes, and compiles agency records sought by the public under the New York State Freedom of Information Law (FOIL). In collaboration with the appropriate Board staff, the Office coordinates the photocopying of records, gathering of electronic documents for transmittal, and scheduling of physical inspections of original documents by those individuals and entities seeking such public records. In addition, prior to its release, the Office reviews and redacts any information contained in the public records which by law are exempt from disclosure. It also processes any appeals for submission to the Commissioners of Elections.
